

Jennifer Stumm, viola performs on April 6



Hailed as "outstanding" by *The Strad*, Jennifer Stumm is the recipient of First Prize in the 2006 Concert Artists Guild International Competition. Recognized for her unique musical voice and commanding stage presence, she is the first solo violist in the nearly 60-year history of the CAG Competition to achieve this honor. Prior competition successes include those at the William Primrose Viola Competition and the Vrienenkrans Concours of Amsterdam's Concertgebouw, both in 2005.

The 2007-8 season includes Ms. Stumm's recital debut at the Kennedy Center on the Washington Performing Arts Society Series, plus appearances at Wigmore Hall in London, Ravinia's "Rising Star Series" and a performance of the Walton Viola Concerto with the New Haven Symphony.

Jennifer Stumm is a member of the London-based Aronowitz Ensemble and a regular participant at the International Musicians Seminar at Prussia Cove, both in Cornwall,

England, and on tour. Ms. Stumm has spent three summers at the Marlboro Music Festival and appeared at the Steans Institute at Ravinia, the Aldeburgh Festival, Kronberg Academy and Switzerland's Verbier Festival.

A native of Atlanta, Jennifer Stumm began viola studies at the age of eight. She holds a Bachelors of Music degree from The Curtis Institute where she was a student of Karen Tuttle. While in Philadelphia, she pursued concomitant interests in astrophysic and politics at the University of Pennsylvania. Ms. Stumm followed here Curtis Institute degree with a Masters of Music from The Julliard School where she studied with Samuel Rhodes. Currently she divides her time between musical commitments in the US and Europe, where her recent mentors have been violist Noboku Imai and cellist Steven Isserlis. She plays a 1767 Mantegazza viola.

She will be accompanied by Elizabeth Pridgen on piano.

New Discoveries Adding to Our Knowledge of Mozart and His Life Rare Mozart portrait discovered

A portrait of Wolfgang Amadeus Mozart that lay unidentified for more than 200 years has been proved to be authentic, according to an expert on the composer.

Professor Cliff Eisen from London's King's College has spent more than a year trying to confirm that the picture was of Mozart, who died in 1791.

He said: "This is arguably the most important Mozart portrait to be discovered since the composer's death." Its significance came to light after it was bought by a US collector in 2005.



The portrait of Mozart shows the composer in profile in a red jacket. Prof Eisen said the coat was almost exactly the same as one Mozart described to his father in a letter on 28 September 1782, even down to the buttons.

The picture is thought to date from about 1783 and be the work of Austrian artist Joseph Hickel.

King's College said the portrait was previously owned by the family of Johann Lorenz Hagenauer, a close friend and one-time landlord of the Mozarts in Salzburg, Austria. A family story suggested Hickel gave Mozart the portrait after Mozart composed the wind serenade K375 for a member of Hickel's family.

"Given that there are very few authentic pictures of Mozart from the last 10 years of his life, the discovery is an inherently significant one.

"Needless to say, it will encourage us to think afresh about Mozart's appearance."

Photo of Mozart's widow found

A print of the only photograph of Mozart's widow, Constanze Weber, has been found in Germany.

The photograph was taken in 1840 in the Bavarian town of Altoetting when she was 78. She died two years later.

The local authorities say detailed examination has proved the authenticity of the image, which is a copy of the original daguerreotype.

The print is one of the earliest examples of photography in Bavaria. It was found in the town archives.

The daguerreotype was taken at the home of the Swiss composer Max Keller, whom Constanze used to visit regularly.

Mozart and Constanze had six children in their nine-year marriage. Only two of them survived past childhood.



The daguerreotype shows Constanze at front left, next to Max Keller. His wife Josefa is on the right. Behind them are (from the right): their daughters Josefa and Luise, Max Keller's brother-in-law Philipp Lattner and the family's cook. They are outside the Keller family's house.
